Pavilion Reservation Form

Beginning the first business day of January, the Dorr Township parks commission will begin accepting reservations for the park pavilions for the current year. Reservations will be made on a first come, first serve basis by calling 616-681-9874 or visiting the Township Office located at 4196 18th St. Payment will be required within 10 days of the date reservation is made. If payment is not received within 10 days, the reservation will be automatically canceled. All fees are non-refundable.

PARK RENTAL FEES

NORTH PARK includes shelter and kitchen area; \$75.00

SOUTH PARK includes shelter, kitchen area and indoor restrooms; \$150.00

MOLINE PARK includes open shelter area only; \$25.00

A \$100.00 DEPOSIT IS REQUIRED along with the rental fees for all park rentals. The amount of the deposit to be refunded will be determined by the Parks Commission upon inspection by the Park and Building Maintenance Supervisor.

A clean up fee of \$10.00 per hour will be subtracted from the deposit if the properties are left in unsatisfactory condition. A separate check is required for the deposit and will be returned upon inspection.

Dorr Township Parks Rules and Regulations

1. Park hours are from 8:00 a.m. to 10:00 p.m.
2. Picnic tables are not to be removed from the park
3. No open fires
4. No overnight camping
5. No alcohol
6. No motorized vehicles in grassy areas and on ball diamonds
parking in designated areas only
7. No fireworks
8. No hunting
9. Pets must be leashed and cleaned up afterwards
10. No rowdyism
11. Parents will be responsible for childrens actions
12. No destruction of natural surroundings
13. No soliciting
14. Vandalism will not be tolerated
15. Tennis courts are not to be used for street hockey or rollerblading
