

DORR TOWNSHIP BOARD MEETING HELD SEPTEMBER 4, 2008

Meeting called to order by Supervisor Kaczanowski at 7:00 p.m.

The Pledge of Allegiance was recited.

MEMBERS PRESENT: Don Kaczanowski, Jodi Brummel, Jan Saunders, Larry Dolegowski, Tammy VanHaitsma, Paul Davis, and Don VanDorp.

MEMBERS ABSENT: None

VanHaitsma moved and seconded by Dolegowski to approve the minutes of the regular meeting held August 21, 2008. Motion carried.

Public comments included an inquiry regarding the old Crown Vic police vehicle and the ACR bill and request to add discussion regarding the DDA Board on the agenda.

Davis moved and seconded by Kaczanowski to add "DDA Board discussion" to next meeting's agenda.

No changes or additions to the agenda.

VanDorp moved and seconded by Saunders to approve bills in the amount of \$70,301.26. Motion carried.

No communications.

The following reports were given: 1) Planning Commission by Larry Dolegowski; 2) Library by Gordon Lieffers; and 3) Fire Department by Assistant Chief Fifelski.

Old business included:

1) Drainage problem on Junglas property

Larry Dolegowski met with the Schumaker residence to discuss the drainage problems and inquire whether they were willing to pay one-third of the cost of installing a tile to resolve the problems. The Schumaker's indicated they did not feel it to be their obligation to pay a portion of the cost. Supervisor Kaczanowski to check further with the County Drain Commission due to expressed concern of trees being planted in the retention area.

New business included:

1) Approval of Wind Energy System Ordinance

Dolegowski moved and seconded by VanHaitsma to approve the Wind Energy System Ordinance, as recommended by the Dorr Township Planning Commission on July 15, 2008, and the Allegan County Planning Commission in August, 2008. Roll Call Vote: VanDorp YES; Brummel YES; Kaczanowski YES; Saunders YES; Davis YES; Dolegowski YES; and VanHaitsma YES (7YES, 0 NO). Motion carried.

2) Approval of MET Tower Ordinance

Davis moved and seconded by Saunders to approve the MET Tower Ordinance, as recommended by the Dorr Township Planning Commission on July 15, 2008, and the Allegan County Planning Commission in August, 2008. Roll Call Vote: Kaczanowski YES; Davis YES; VanHaitsma YES; VanDorp YES; Saunders YES; Brummel YES; and Dolegowski YES (7 YES, 0 NO). Motion carried.

Dolegowski moved and seconded by VanDorp to adjourn. Motion carried.
